1. PURPOSE

1.1 The purpose of this report is to provide a report to the public on the key activities that have occurred since the last public meeting.

2. BUSINESS UPDATE

2.1 Waipuna Road

- 2.1.1 Trading continues to trade moderately above expectations; however, this must be considered in the broader context that Waipuna has only been open to the public for just under fifteen (15) months and is still in the very early stages of the post-COVID hospitality recovery period, despite trading being above expectations, it remains below pre-COVID levels.
- 2.1.2 As is seen in many businesses. The cost of employing and retaining good people continues to remain high.
- 2.1.3 There is significant difficulty in generating acceptable margins with frequent increases in the cost of core of goods.
- 2.1.4 Many businesses and individuals are battling challenging market conditions we have seen this as particularly evident in trying to convert Christmas work and family functions. Businesses and individuals are simply not able to justify expenditure at a level seen historically.
- 2.1.5 Staff, customers, and the public were recently notified that the Western Accommodation Block of the Waipuna Hotel and Conference Centre has been confirmed as an Earthquake Prone Building, having received a 10% BNS rating. A building is considered earthquake prone if it has an NBS percentage of less than 34%.
- 2.1.6 Mount Wellington Trust Hotels, the commercial subsidiary of Mount Wellington Licensing Trust, completed a risk assessment and believes the Western Accommodation Block can continue to be occupied and remain in service while decisions on permanent strengthening solutions are made.
- 2.1.7 A copy of the summary risk assessment infographic is attached to this paper.

2.2 Queen's Road

- 2.2.1 Trading at The Corner Bar continues to be a challenge. Many patrons in the area are particularly hard hit by the cost-of-living crisis, impacting discretionary spending.
- 2.2.2 Effective 01 December, the new harm-minimisation rules are in effect. All team members have received additional training to comply with the new standards.
- 2.2.3 Following the opening of the RSA across the road, the challenging trading conditions have been further strained.

2.3 Highbrook

2.3.1 In the interest of achieving the best and most efficient operational efficiency at Waipuna, Highbrook business has been relocated to Waipuna.

2.4 Mount Wellington Charitable Trust

- 2.4.1 Mount Wellington Charitable Trust is arranging the delivery of a Christmas treat to the retirement village and rest home residents in the weeks leading up to Christmas.
- 2.4.2 The Trustees believe this this is a great way to bring a bit of festive cheer to our senior's community.

2.5 Audit Delays


- 2.5.1 The annual financial statements for the period ending 31 March 2023 have been delayed following complexities that have arisen from asset valuation and associated disclosures from the outcomes of the seismic status of the Western Accommodation Block.
- 2.5.2 Financials are likely to be prepared early in the 2024 year with an AGM to be held within the required two-month period following the completion of the financials.

3. OUR PEOPLE / HEALTH & SAFETY

- 3.1 The Health & Safety committee continue to meet regularly and have made considerable progress on a range of initiatives to ensure our businesses are a safe place to work.
- 3.2 Staff training on armed robbery and emergency evacuation has taken place in recent months.

WHAT THIS MEANS

% NBS is an index used to characterise the expected seismic response of a building to earthquake shaking relative to new building standards.

- **NBS >67%:** Low risk, not considered to be potentially earthquake prone.
- **NBS 34%–66%:** Medium risk, not considered to be potentially earthquake prone.
- NBS <34%: High risk, considered to be potentially earthquake prone. This is considered an "Earthquake Prone Building". We must prominently display an Earthquake Prone Building notice.

WESTERN ACCOMMODATION BLOCK EARTHQUAKE RISK ASSESSMENT

Mount Wellington Trust Hotels, as building owner, has conducted a detailed risk assessment concluding that it is reasonable to occupy the building and that business can continue as usual.

OVERALL RISK ASSESSMENT



WHAT THE LAW SAYS

- We must assess the building and its risks, and notify Auckland Council.
- We must prominently display an Earthquake Prone Building notice.
- We must carry out building work to ensure that the Western Accommodation Block is no longer earthquake prone by 2058 (35 years).
- We must notify and discuss the risks with staff.

DID YOU KNOW?

- Earthquake prone buildings are not considered dangerous, and may continue to be used/ occupied (Building Act).
- In general, a low %NBS means no need for alarm or immediate action. The life safety risk is still very low.
- There is no legal requirement to close a building based solely on a low %NBS rating
